Calvin Doering will retire after 27 years of service to the citizens of the state of Wisconsin





## ***Retirement Resolution***

Calvin Doering will be retiring from the Wisconsin Department of Natural Resources on June 19, 2009 after completing 27 1/2 years of outstanding service to the people of Wisconsin. His last day in the office will be June 19, 2009.

Calvin began his career with the DNR on January 1, 1982 stationed at the Tomahawk Training Center for three months of new forester training. After his training, Calvin was transferred to the Barnes Ranger Station where his first permanent assignment was forester for the Bayfield County Forest. In 1984, after 2 ½ years with Bayfield county, Calvin took a lateral transfer as forester on the Northern Highland American Legion State Forest at Woodruff. Calvin worked 8 years on the State Forest before transferring to Rhinelander to work as liaison forester on the Oneida County Forest. In 1994, Calvin transferred back to the NHAL to work the remainder of his forester career. His focus on the State Forest has always been forest management, primarily the timber sale program.

Throughout his career, Calvin has always conducted his business in a professional and dedicated manner in service to the department and his community. As forester on the NHAL State Forest for over 27 years, Calvin has worked many job duties throughout the largest state property in Wisconsin. Among his major duties and responsibilities was the establishment of 119 timber sales totaling approximately 15,000 acres. Calvin served as lead worker on the American Legion portion of the State Forest, directing forestry work out of the Woodruff Annex forestry office. His active contribution to the Area Fire Program was as Overhead Forester and Plans Section Chief on the Incident Management Team.

Calvin has tirelessly served the general public and his colleagues in a spirit of professionalism, courtesy and dedication throughout his career. Projects and relationships that Calvin has cultivated will continue to grow, and the public will benefit from Calvin's service for years to come.

***WHEREAS***, Calvin Doering has served the people of the State of Wisconsin faithfully and well in the performance of duties and has thus earned the commendation due an exemplary public employee;
