

SUBJECT: LAND ACQUISITION - JOHN MICHAEL KOHLER STATE PARK – SHEBOYGAN COUNTY

FOR: DECEMBER 2007 BOARD MEETING

SUMMARY: The Department has obtained an option to purchase 40 acres of land from Lloyd and David Gartman for \$372,000 for the John Michael Kohler State Park. The item requires Board action since the purchase price exceeds \$150,000.

The park is located in eastern Wisconsin on the shore of Lake Michigan two miles south of Sheboygan. It is one of two project areas that together are managed as the Kohler-Andrae State Park. The other project area is the Terry Andrae State Park, which abuts the south edge of John Michael Kohler State Park.

The Terry Andrae State Park established in 1929 with a gift of land and John Michael Kohler State Park was established in 1966. Together, the parks provides recreational opportunities on more than 1,100 acres of land along the Lake Michigan shoreline, including camping, fishing, swimming, picnicking, hiking, nature study, boating, cross-country skiing, and muzzleloader and late archery hunting for deer. Annual visitor numbers is 446,000 with 60,000 camper days. The park has 105 campsites, six miles of walking trails, and three miles of horse trails.


Acquisition of the property will help protect the state's ownership to the north, south and east, preventing incompatible development, as well as helping protect water quality of the Black River within the park. More than 2,000 feet of two small tributaries to Black Creek bisect the property. This parcel contains the shoreline of glacial Lake Nipissing that includes wetland complexes and remnant maple-beech forest community. The park's feasibility study proposes to protect the 14-foot scenic sand ridge of Lake Nipissing as a shortgrass prairie, providing habitat for several rare moth and butterfly species. The park will soon have a bird-hiking trail since bird watching is a significant activity enjoyed by the public. The parcel is frequented by killdeer and shorebirds. After wetland restorations and prairie plantings, the Gartman property will provide valuable wildlife habitat.

RECOMMENDATION: That the Board approve the purchase of 40 acres of land for \$372,000 for the John Michael Kohler State Park.



2. JUSTIFICATION:

The Department has obtained an option to purchase 40 acres of land from Lloyd and David Gartman for John Michael Kohler State Park. The park is located in eastern Wisconsin along the shore of Lake Michigan two miles south of Sheboygan and 42 miles north of Milwaukee. It is one of two project areas that together are managed as the Kohler-Andrae State Park. The other project area is the Terry Andrae State Park, which lies to the south of John Michael Kohler State Park.

The Terry Andrea State Park established in 1929 with a gift of land and John Michael Kohler was established in 1966. The joint park provides recreational opportunities on more than 1,100 acres of land along the Lake Michigan shoreline, including camping, fishing, swimming, picnicking, hiking, nature study, boating, cross-country skiing, and muzzleloader and late archery hunting for deer. Annual visitor numbers is 446,000 with 60,000 camper days. The park has 105 campsites, six miles of walking trails, and three miles of horse trails.

The park protects rare plant communities and critical habitat for endangered and threatened species. Some of the significant plant and animal communities and geologic features are the lake dunes, wetlands between the dunes, the beach, the former shoreline of an ancient lake, and the Black River fishery and associated wetlands.

Acquisition of the property will serve as a buffer to protect the state's ownership to the north, south and east, preventing incompatible development, as well as helping protect water quality of the Black River. More than 2,000 feet of two small tributaries to Black Creek bisect the property. This parcel contains the shoreline of glacial Lake Nipissing that includes wetland complexes and remnant maple-beech forest community. The park's feasibility study proposes to protect the 14-foot scenic sand ridge of Lake Nipissing as a short grass prairie, providing habitat for several rare moth and butterfly species. The park will soon have a bird-hiking trail since bird watching is a significant activity enjoyed by the public.

The Department recommends purchase of the Gartman 40-acre tract for \$372,000 for the John Michael Kohler State Park to provide additional recreational opportunities, prevent incompatible development, and to protect water quality. Restoration of wildlife habitat will be done with wetland restoration and prairie grass planting as the cropland use is phased out.
