PUBLIC NOTICE OF INTENT TO REISSUE A WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM (WPDES) PERMIT No.WI-0020303-10-0

Facility Where Discharge Occurs: Hustisford Wastewater Treatment Facility, 500 INDUSTRIAL LANE, HUSTISFORD, WISCONSIN

Receiving Water And Location: Rock River (Sinissippi Lake Watershed, UR08 – Upper Rock River Basin) in Dodge County, SE ¼ of SW ¼, Section 15, T10N, R16E Lat: 43.33084° N / Lon: 88.58912° W

Brief Facility Description and Summary of Proposed Changes: The Village of Hustisford operates a wastewater treatment facility for the Village of Hustisford, the Hubbard-Hustisford Sanitary District No. 1 and the Hubbard Sanitary District No. 2 serving a total population of approximately 2,400 residents with no significant industrial contributors. The treatment plant consists of three aerated ponds where treatment occurs before being discharged to the Rock River daily on a year-round basis. Lagoon 1 is 10 feet deep and holds roughly 3.18 million gallons. Lagoon 2 is approximately 9 feet deep and holds roughly 2.18 million gallons. Lagoon 3 is about 6 feet deep and holds around 5.82 million gallons. The design flow of the facility is 0.236 MGD with an average of 0.176 MGD discharged daily. Phosphorus treatment is performed by chemical removal. Solids that settle are stored in the lagoons and periodically removed and land applied on DNR approved sites. Solids were last removed from the lagoons in 2010.

The Department has tentatively decided that the above-specified WPDES permit should be reissued.

Limitations and conditions which the Department believes adequately protect the receiving water are included in the proposed permit. Land application of waste shall be done in accordance with permit conditions and applicable codes. All land application sites shall be approved prior to their use. To receive a list of approved sites, or to be notified of potential approvals, contact the above-named basin engineer.

Persons wishing to comment on or object to the proposed permit action, or to request a public hearing, may write to the Department of Natural Resources at the above-named permit drafter's address. All comments or suggestions received no later than 30 days after the publication date of this public notice will be considered along with other information on file in making a final decision regarding the permit. Anyone providing comments in response to this public notice will receive a notification of the Department's final decision when the permit is issued. Where designated as a reviewable surface water discharge permit, the U.S. Environmental Protection Agency is allowed up to 90 days to submit comments or objections regarding this permit determination. If no comments are received on the proposed permit from anyone, including U.S. EPA, the permit will be issued as proposed.

The Department may schedule a public informational hearing if requested by any person and shall schedule a public informational hearing if a petition requesting a hearing is received from 5 or more persons or if response to this notice indicates significant public interest pursuant to s. 283.49, Wis. Stats. Requests for a public informational hearing shall state the following: the name and address of the person(s) requesting the hearing; the interest in the proposed permit of the person(s) requesting the hearing; the reasons for the request; and the issues proposed to be considered at the hearing.

Information on file for this permit action, including the draft permit, fact sheet and permit application, may be inspected and copied at either the above-named permit drafter's office or the above named basin engineer's office, Monday through Friday (except holidays), between 9:00 a.m. and 3:30 p.m. Please call the permit drafter or basin engineer for directions to their office location, if necessary. Reasonable costs (15 cents per page for copies and 7 cents per page for scanning) will be charged for information in the file other than the public notice, permit and fact sheet.
