Provision Pertaining to the Wisconsin Ozone State Implementation Plan (SIP)

NOTICE IS HEREBY GIVEN THAT pursuant to s. 285.13(1), Wis. Stats., and 40 CFR § 51.102 the Department of Natural Resources will hold a public hearing regarding the development and requested approval under s. 285.11(6), Wis. Stats., of a base emissions inventory for a portion of Kenosha County and the whole of Sheboygan County prepared as part of the SIP to fulfill requirements under the 2008 ozone national ambient air quality standard (NAAQS).

**Background**

The Clean Air Act (CAA) requires establishing a base inventory of nitrogen oxides (NOx) and volatile organic compound (VOC) emissions for areas that are in nonattainment for the ozone NAAQS. The Department has developed and is proposing to use the 2011 emissions inventory in fulfilling the requirements for establishing a base emissions inventory for the portion of Kenosha County and the whole Sheboygan County that are nonattainment for the 2008 Ozone NAAQS. This base emissions inventory will be used to measure future emission reductions in progressing towards attainment. Pursuant to 40 CFR § 51.102, the public must be provided the opportunity to comment on any element being proposed for approval to the SIP. This comment period fulfills this requirement for submitting the base emissions inventory for the portion of Kenosha County and Sheboygan County.

**Action Subject to Comment**


The Department is soliciting comment on all elements regarding development of the 2011 emissions inventory and use of the 2011 emissions inventory as the base inventory in fulfilling requirements for the portion of Kenosha County and whole of Sheboygan County that are nonattainment for the 2008 ozone NAAQS.
