




**WISCONSIN DNR

The Department of Natural Resources conducted a fisheries assessment of Balsam Lake, Polk County, from April 18, 2011 to April 23, 2011.


Balsam Lake is a drainage lake in the St. Croix River basin. The walleye fishery is supported primarily through stocking. The population estimate for adult walleye was comparable to lakes with similar characteristics.

General Fishing Regulations for Balsam Lake, Polk County, 2011

FISH SPECIES	OPEN SEASON	DAILY LIMIT	MINIMUM LENGTH
Walleye	May 07-March 04	2	15" MINIMUM
Largemouth and Smallmouth Bass	May 07-March 04	5	NO MINIMUM, 1 <14"
Muskellunge	May 28-November 30	1	40" MINIMUM
Northern Pike	May 07-March 04	2	26" MINIMUM
