Major points of interests are the historic bridge in Belleville, the curved tunnel in the Town of Exeter and the site of the Historic Woolen Mill in Monticello. <p><u>Access and Use by Persons with Disabilities</u></p> <ul style="list-style-type: none"> All trail facilities including drinking fountains, rest rooms, parking, telephones, etc., will be accessible to people with disabilities. The trail, because of its nearly level grade, will be very accessible to and usable by those who use wheelchairs and other mobility aids. Nature interpretation labels and/or brochures will have large print to insure readability by those with visual impairments.
