<p><b>MASTER PLAN OBJECTIVES</b></p> <p>Fisheries Mtg.</p>	<p><u>High Priority</u></p> <ul style="list-style-type: none"> <li>• Dredge the eastern ½ of Puckett's Pond to at depth of 15'</li> <li>• Develop a disabled-accessible fishing pier on the east end of Quarry Lake and a bridge over each of the two Quarry Lake-Lake Michigan inlets leading to the pier.</li> <li>• Develop a disabled-accessible fishing pier on the north or east shore of Puckett's Pond</li> </ul> <p><u>Medium Priority</u></p> <ul style="list-style-type: none"> <li>• Stock Puckett's Pond annually with quality-size hybrid sunfish</li> <li>• Stock Quarry Lake with 1,250 small fingerling smallmouth bass each year for three years.</li> </ul>

<p style="text-align: center;"><b>MASTER PLAN OBJECTIVES</b></p> <p>Cultural Resource Mtg.</p>	<ul style="list-style-type: none"> <li>• Plant culturally sensitive areas to protect them from future disturbance and looting.</li> <li>• Negotiate with the Wisconsin Historical Society to mitigate adverse effects on cultural resources before any land disturbance activities in accordance with Section 106 of the federal Historic Preservation Act of 1966 as amended and s. 44.40, Wisconsin Statutes.</li> <li>• Consider alternate uses, intact sale, or donation of significant historic structures before demolition. If this is not possible, fully document these structures before removal.</li> <li>• Provide interpretive and educational programs on cultural resources.</li> <li>• Provide educational literature on the preservation and protection of archeological and historic sites.</li> <li>• Prohibit the unauthorized collection of artifacts on any land within the park.</li> <li>• Encourage and maintain the friends group to aid in the protection and preservation of known sites and the discovery of new ones.</li> <li>• Work with special interest groups to protect ethnically sensitive areas within HBSP.</li> </ul>
